Application requirements for obtaining a Fence Permit

- Completed fence permit application.
- Provide a plot plan indicating fence location on the property and linear feet of fence (single-family may use diagrams on back).
- Indicate height(s) of proposed fencing on attached diagram sheet.
- Fence on properties other than single family residential requires planning department approval.
- Fencing for a swimming pool must meet the requirements of the *Michigan Residential Code*.

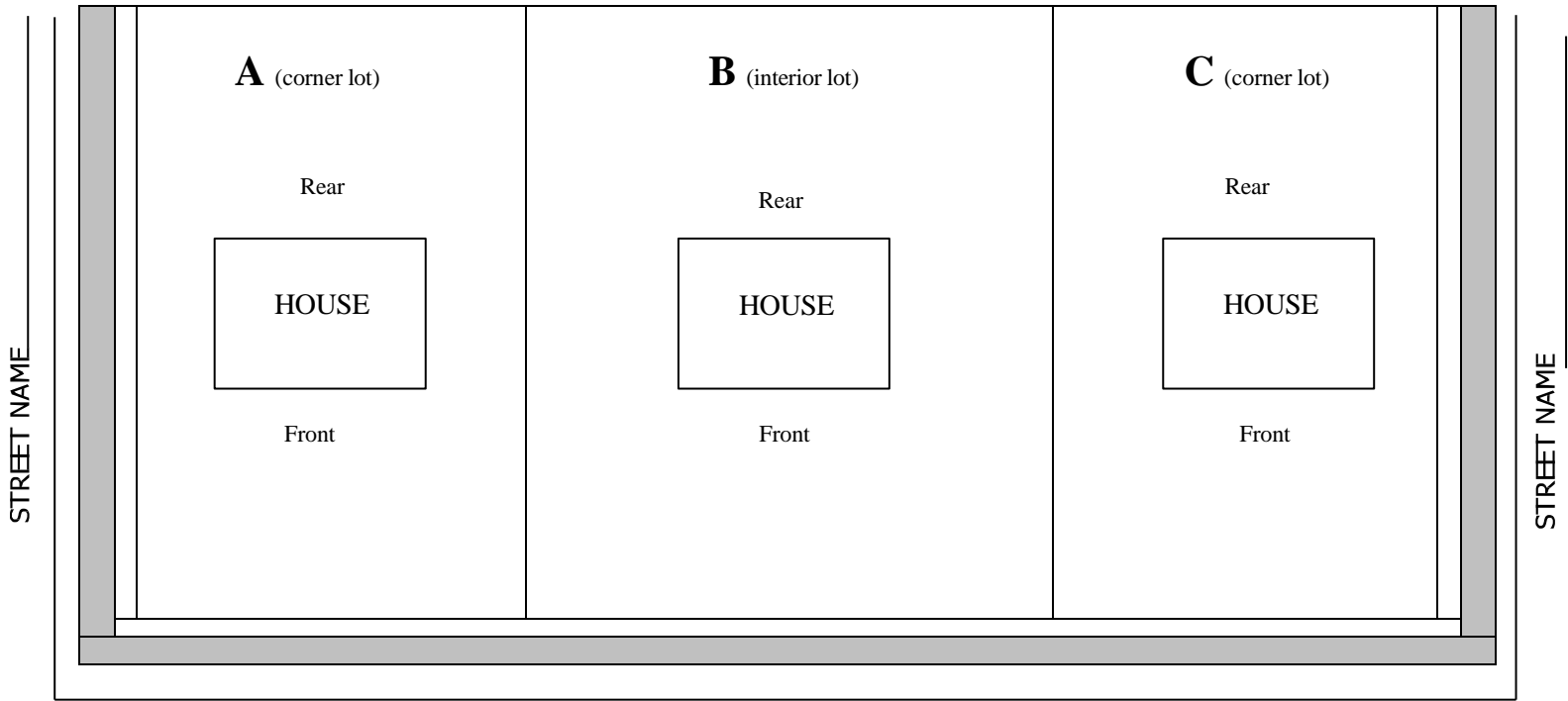
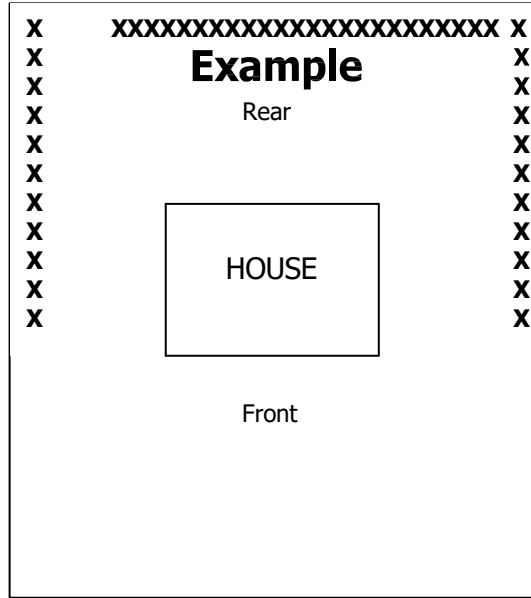
Note: Fences, including their supporting posts, must be located within the lot lines of the property where they are installed. This is an approval from the village only.

It is the responsibility of the applicant that the proposed fence is constructed according to the submitted plot plan.
